### **TERMS OF REFERENCE**

#### **FILM DEVELOPMENT ON PERMATA PROJECT IMPACTS IN RELATION TO CLIMATE CHANGE**

#### **Background**

The PERMATA Project is a five-year project dedicated to enhancing the rights and livelihoods of indigenous peoples and local communities in Indonesia. Funded by the Norwegian Agency for Development Cooperation (NORAD), the project focuses on six regencies: Malinau (Kalimantan Utara), Kapuas Hulu (Kalimantan Barat), Merauke (Papua Selatan), Jayapura (Papua), Teluk Bintuni (Papua Barat), and Tambrauw (Papua Barat Daya).

Led by the Samdhana Institute, the project works in collaboration with a consortium of organizations: Badan Registrasi Wilayah Adat (BRWA), Urban and Regional Development Institute (URDI), Kitong Bisa Foundation (KBF), Rainforest Foundation Norway (RFN), PEREMPUAN AMAN, and Kaoem Telapak. Together, they support the development of Papua and Papua Barat while aligning with Indonesia's commitment to the Paris Agreement, the Local Community & Indigenous Peoples (LCIP) initiative, and the CBD (8J) Direct Funding Mechanism. The project specifically targets indigenous peoples and local communities living in and around forest areas, alongside local governments and civil society organizations.

Focusing on improved rights and livelihoods for IPLCs living in tropical forests, PERMATA Project is crucial, and it gives significant contributions to the reduction of greenhouse gas emissions. PERMATA Project outcomes lead to the improvement of livelihoods and more secure rights over land and natural resources.

Initiated in 2020, PERMATA Project is now in its final year. Numerous activities derived from its outcomes have been done in the projects working areas, in six regencies. In this final year, PERMATA Project is working on the final report and the development of four short films about the progress of the project.

#### **Objective of the Assignment**

The objective of this assignment is to produce four (5) short films, with a duration of between 5-8 minutes. The four short films will be about the progress and/or achievement of PERMATA Project focusing on livelihoods and recognition of indigenous territories, and they should be related to the contributions to the reduction of greenhouse gas emission. The details of the films are as follows:

- One short film about livelihoods program for four clans in Teluk Bintuni Regency (clans of Yen, Yec, Masakoda, and Ogoney). This film portrays the progress of efforts made by PERMATA Project in Teluk Bintuni regency, especially in supporting Yen, Yec, Masakoda, and Ogoney clans in developing their commodities to generate income.

- One short film about livelihoods program in Kampung Wertam, Distrik Bikar, of Tambrauw regency, Papua Barat. In this kampung, the community had developed a mini market. This mini market is managed by Kelompok Tani Yaf Kayam, which is a part of Kampung Wertam.
- One short film about the recognition of indigenous territory in Merauke. This will focus on *Suku Yei*.
- One short film about the recognition of indigenous territory in Kapuas Hulu, focusing on *Suku Punan*.
- One short film about Samdhana and climate change.

### **Locations for the videos**

The locations included in these four short films will be: Tambrauw Regency, Teluk Bintuni Regency, Merauke Regency, and Kapuas Hulu Regency.

### **Scope of Work and Technical Requirements**

Samdhana welcomes creative ideas and suggestions for impactful and innovative delivery of the messages. The films should be produced in English narration, Indonesian subtitle.

The entire video production, i.e., script writing, filming, editing, voicing/ narration, etc., should be done by the contractor. The script writing will involve the management of Samdhana and PERMATA Project, who will prove input and feedback to the scripts, prior to its approval. The expected timeline is as follows:

1. The contractor shall commence the work as soon as possible, immediately upon signing the contract.
2. A detailed timeline, work plan, and budget should be submitted within 14 days.
3. Script writing, including input from the management of Samdhana and PERMATA Project shall be done approximately 1 month.
4. Filming/ footage taking will be done approximately 1 to 1.5 months.
5. Editing and postproduction will be done for approximately 1 month.
6. The rough cut in every phase of each video should be provided to Samdhana for review, comments and approval.

### **Contractor qualifications:**

1. Minimum of five (5) years' documented work experience in the area of film/reportage/documentary writing, producing, directing and editing.
2. Access to high quality filming, light, sound and editing equipment.
3. The ability to operate under strict time limits and apply high production and technical standards for the purpose of maintaining high level of professionalism.
4. Ability to communicate and conduct interviews in Bahasa Indonesia.
5. Track record of successful materials filmed in Indonesia and/or on similar topics would be an asset.

## **Eligibility**

For the above requirements the contractor shall provide the following:

1. The contractor shall provide links to at least 2 work samples demonstrating most relevant previous productions.
2. Provide company/organization CV.
3. Provide the key personnel CVs with detailed functional responsibilities.
4. Detailed list with technical information of the equipment intended to be used, including camera, light, sound, etc.
5. Creative direction: brief creative ideas and suggestions.
6. Detail working timeline.
7. A clear total cost for the final product with the necessary tax calculations.

## **Others**

The representative of the contractor shall need to come to Samdhana Office in Bogor from time to time for coordination purposes.

## Annex

### **SAMDHANA INSTITUTE**

Samdhana Institute was formed in 2003, by a group of conservationists and development experts. **Samdhana's vision is a region where natural, cultural, and spiritual diversity are valued, and where communities have control over their territories and well-being.** Samdhana is working to help the communities to have their land rights for their territories and full recourse to the rule of law. This should be realized through a combination of independent leadership and organization support.

## PERMATA PROJECT

In 2021, the Norwegian Agency for Development Cooperation (Norad) worked together with the Samdhana Institute to undertake an initiative which aims to contribute to the goal of Norway International Climate and Forest Initiative (NICFI) in reducing deforestation and forest degradation in Indonesia. The initiative is called PERMATA Project (Expanding Community Rights, Livelihoods Innovation and REDD+ in Indonesia).

This is a 5-year project (starting in 2021 to December 2025) that directly contributes to Indonesia's commitment in sustainable/low-carbon initiatives and is developed to support the recognition of the rights of IPLCs who live in & around forest areas so that they can obtain a sustainable livelihood. The project also aims to improve the management of land and forest in order to support improvements in deforestation and land degradation in Indonesia.

PERMATA project is implemented in six regencies. These regencies are Jayapura (Papua), Merauke (Papua Selatan), Tamrauw (Papua Barat Daya), Teluk Bintuni (Papua Barat), Malinau (Kalimantan Utara), and Kapuas Hulu (Kalimantan Barat).

In terms of support to Government of Indonesia, PERMATA project contributes to RPJMN (medium term development plan) 2019-2024 regarding the Agrarian Reform and Social Forestry. Furthermore,

the project also supports the Government of Indonesia in accelerating the development in the provinces of Papua, Papua Barat, and Papua Barat Daya, and in Indonesia's committing to Paris Agreement participation of the Local Community and Indigenous Peoples (LCIP).

The project of PERMATA is managed in a consortium, with Samdhana Institute as a leader, with six consortium partners namely Yayasan Badan Registrasi Wilayah Adat (BRWA), Yayasan Urban and Regional Development Institute (URDI), Perkumpulan Kaoem Telapak, Yayasan Kitong Bisa, Perkumpulan Persekutuan Perempuan Adat Nusantara (PEREMPUAN AMAN), and Rainforest Foundation Norway (RFN).

The project is targeting four results or outcomes, namely

- a. Outcome 1: Communities in high-forest districts have more secure rights over land and natural resources.
- b. Outcome 2: Community livelihoods enhanced through improved resource governance and sustainable enterprise development.
- c. Outcome 3: Enabling policies and institutions actively promote and support rights-based community development.
- d. Outcome 4: IPLC communities have the capacity to sustain, protect and manage their forest resources as part of resilient and self-reliant livelihoods.
